Leadership & Management Grant

Up to £1,000 in grant funding to help pay for your training solution

The Leadership & Management Grant is of government funding which will pay for 50% of the fees excluding VAT up to the maximum amount of £1,000. For example:

- If the training programme costs £1,000 + VAT, **you can claim back £500.**
- If the training programme costs £2,500 + VAT, **you can claim back £1000.**

Eligibility Criteria

This offer is available to private sector businesses or social enterprises that:-

- Have fewer than 250 full time equivalent employees, *and*
- Have at least one employee in addition to the senior leader, *and*
- Have the potential for high or fast growth*

How to apply for a grant

Grants are distributed regionally through selected organisations. An impartial and experienced Leadership and Management Adviser will help you identify your personal development needs at a face to face meeting at your place of work or other venue convenient to you.

Practice funds

All GP practices retain a sum for Practice Development so you will need to approach the partners or your practice manager if you are not the manager already.

Most practices will provide some assistance and we will happily answer any questions raised by your partners.

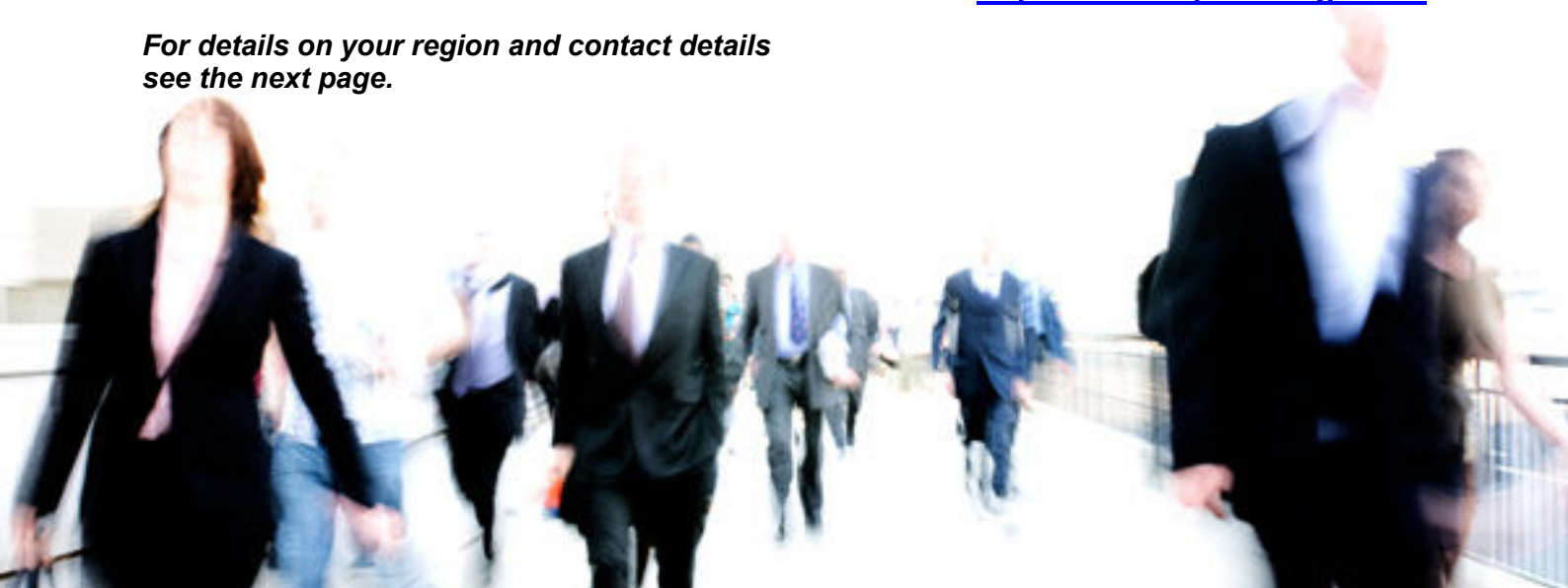
Get advice from 'Next Step'
